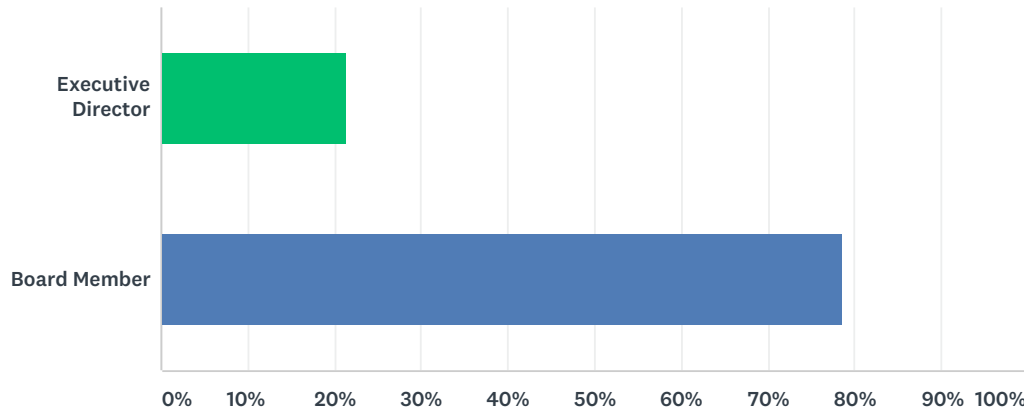


Q1 Are you a Library Executive Director or Board Member?

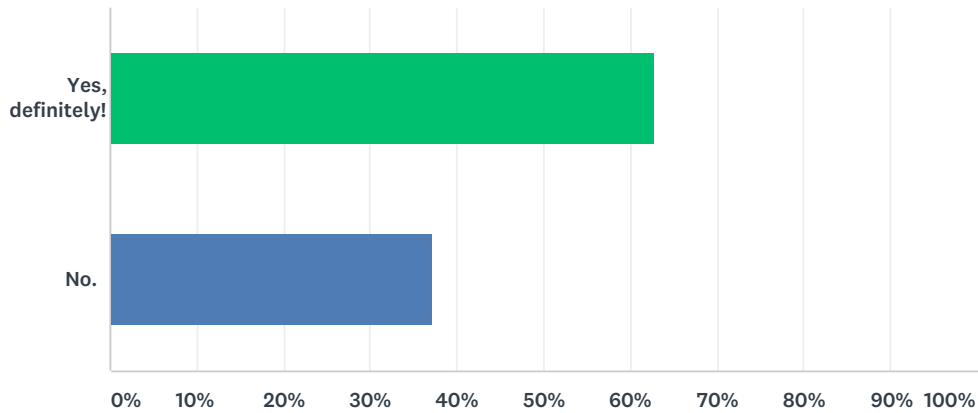

Q2 Are prospective board members made aware of their fundraising responsibilities before they are nominated or appointed onto the library board?

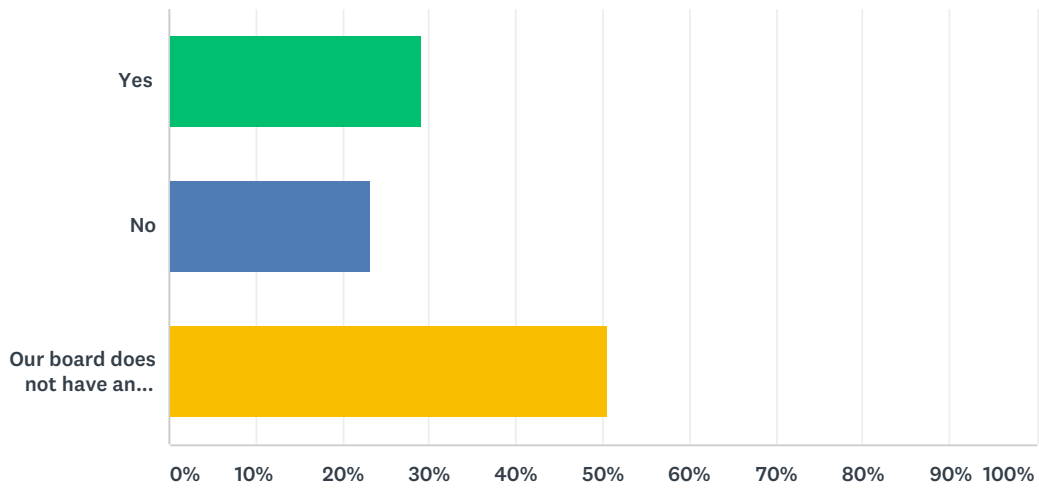

Q3 Are fundraising responsibilities and personal giving included in the annual board member Agreement?

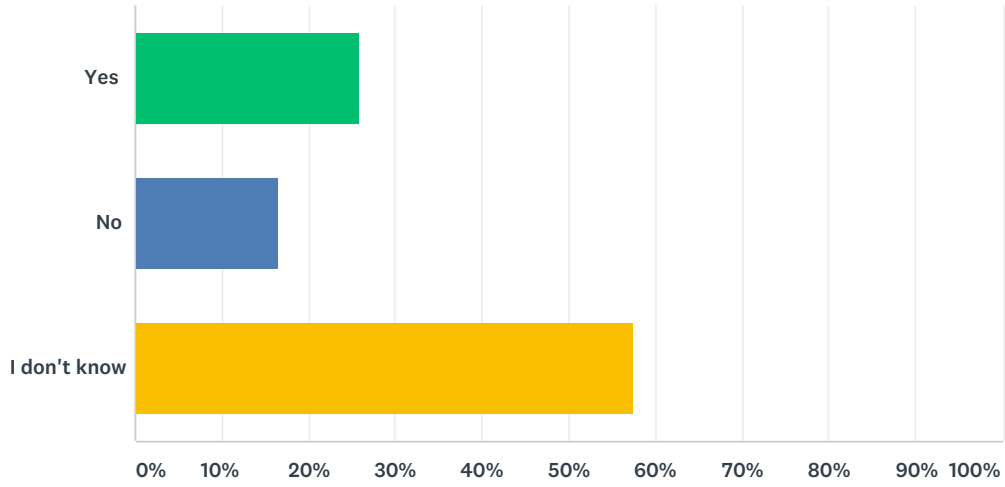

Q4 Do ALL board members make an annual donation to the library?

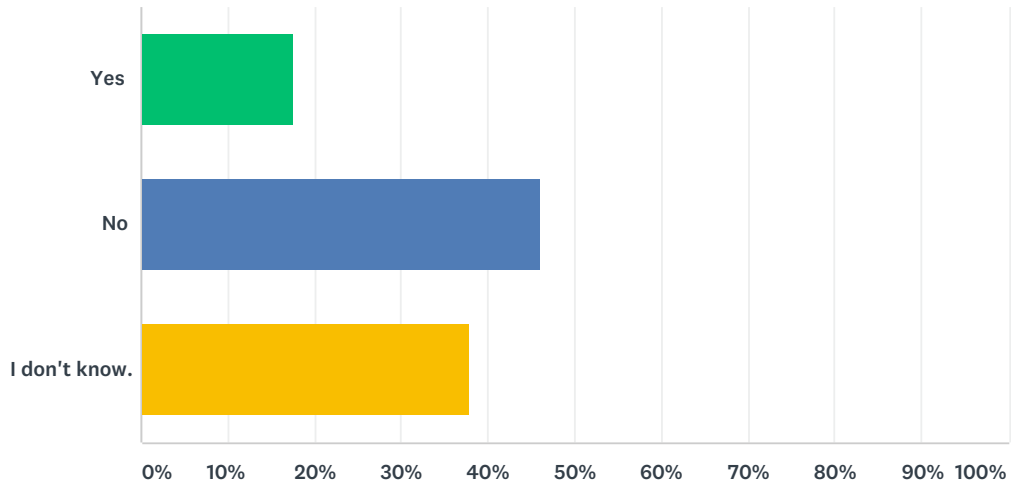

Q5 Does the board president personally solicit board members to ensure annual board giving?

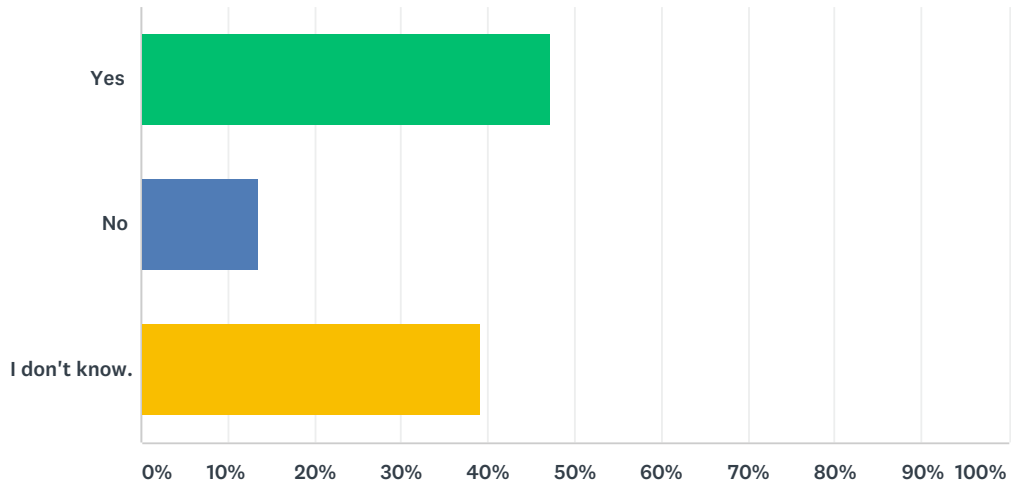

Q6 Does the board president personally identify and build relationships with higher level donors?

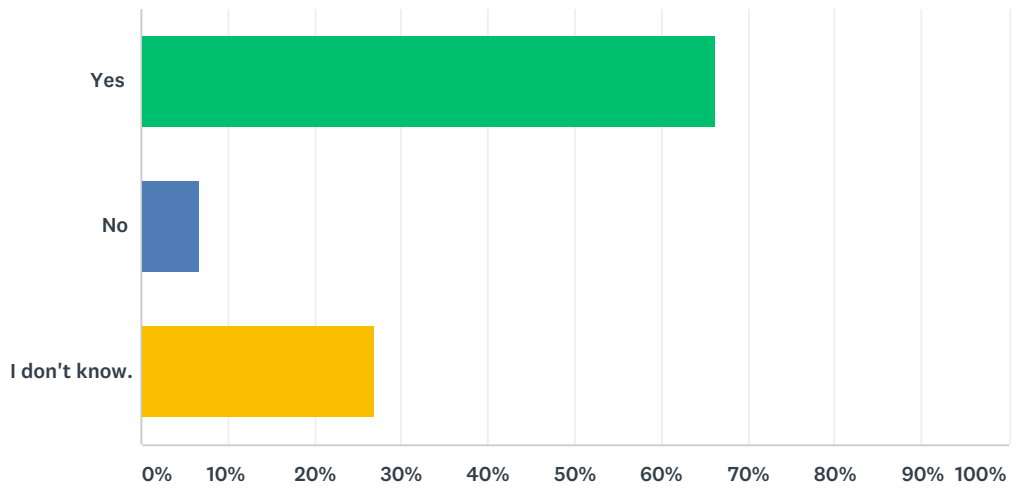

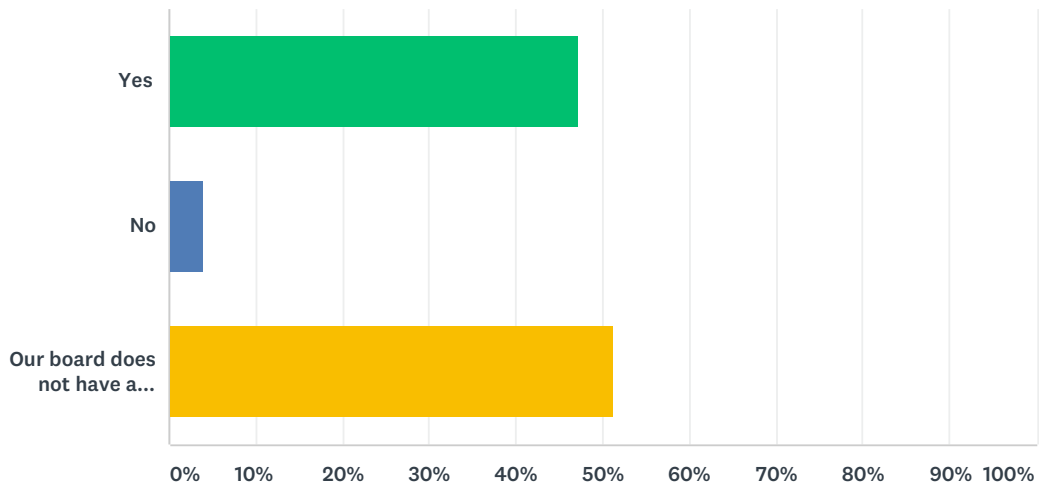

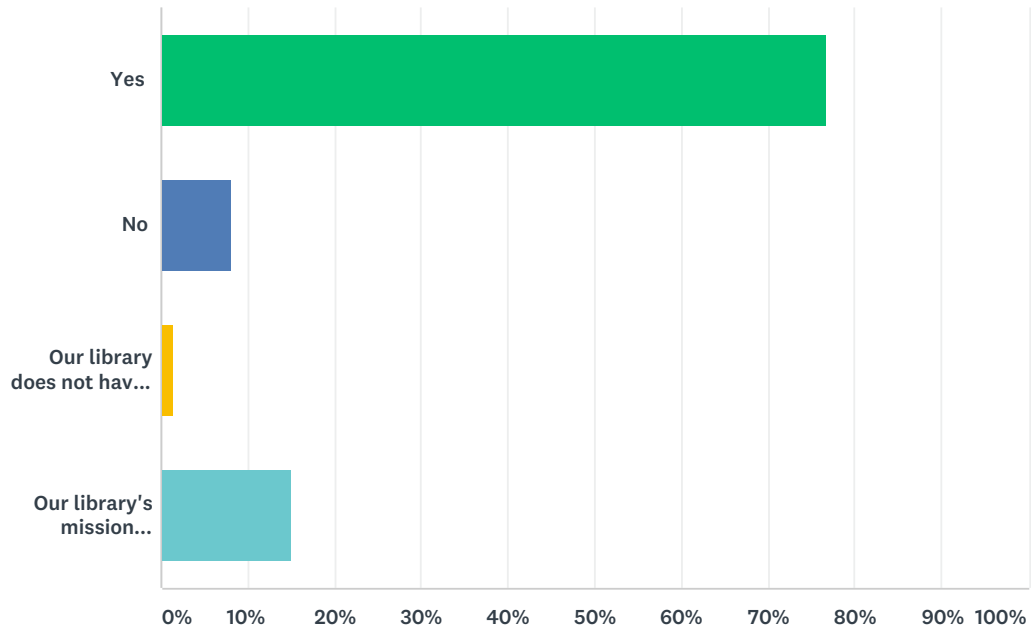

Q9 Is your library's mission clear, concise and compelling?

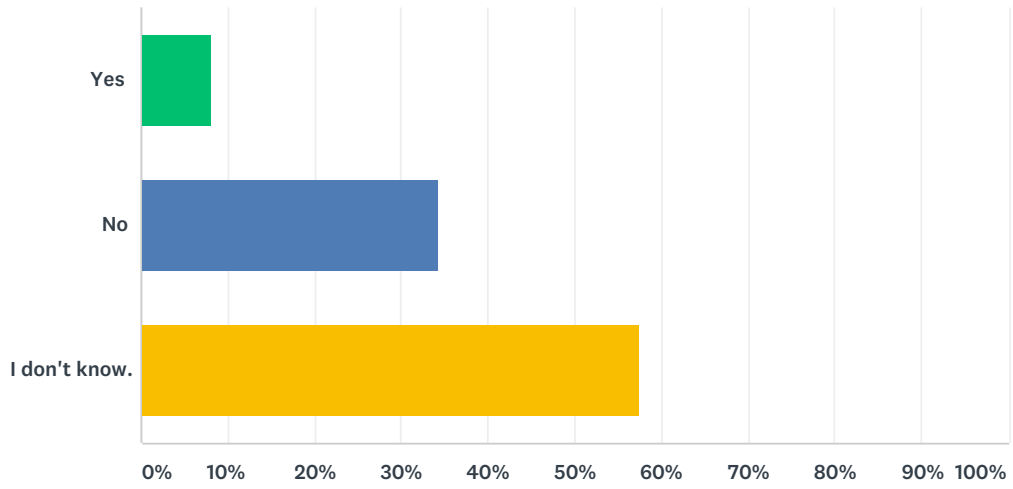

Q10 Can all of the board members recite the library's mission?

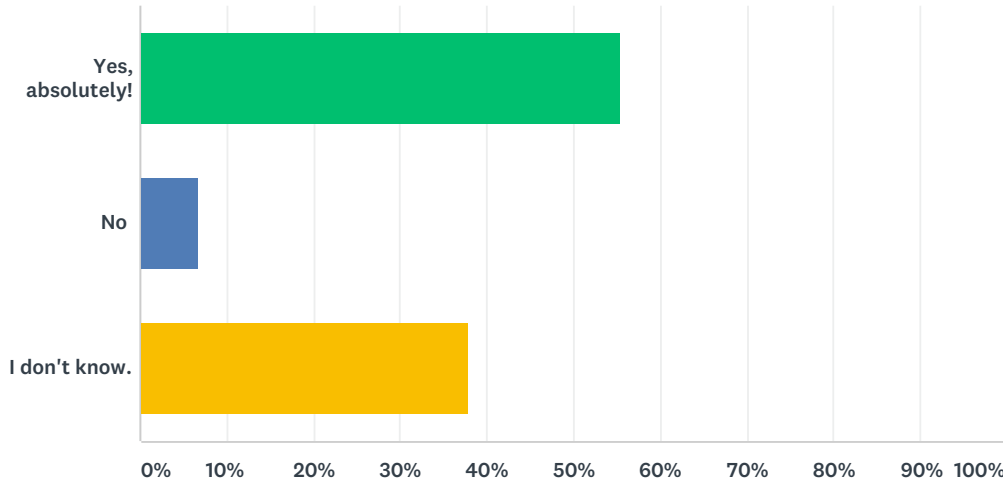

Q11 Can the library board members convincingly and passionately articulate a case for financial support to community stakeholders and funders?

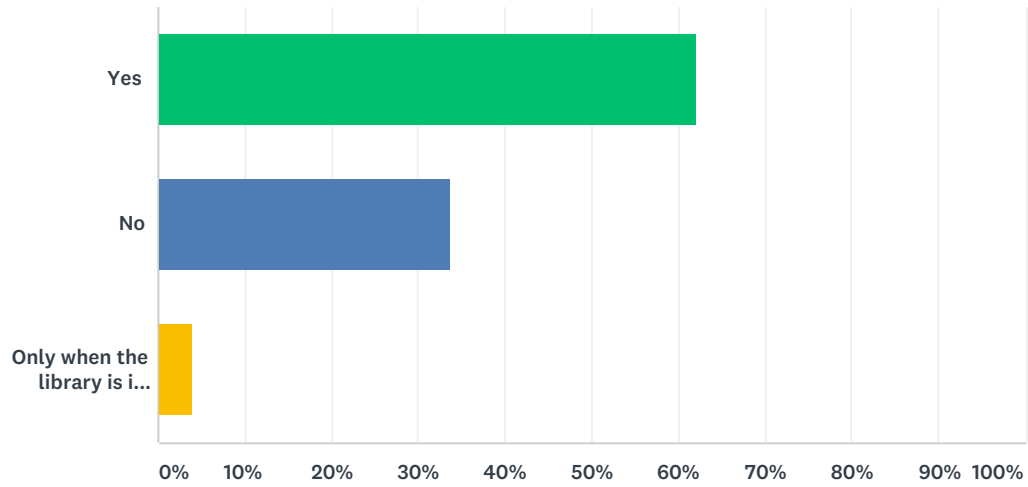

Q12 Does the monthly board meeting agenda give clear priority to fundraising?

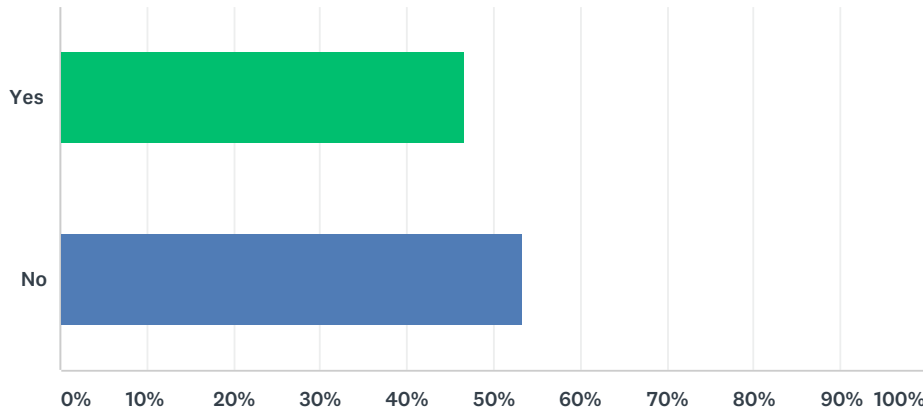

Q13 Does the board develop a fundraising plan and calendar for the upcoming year with clear roles and expectations?

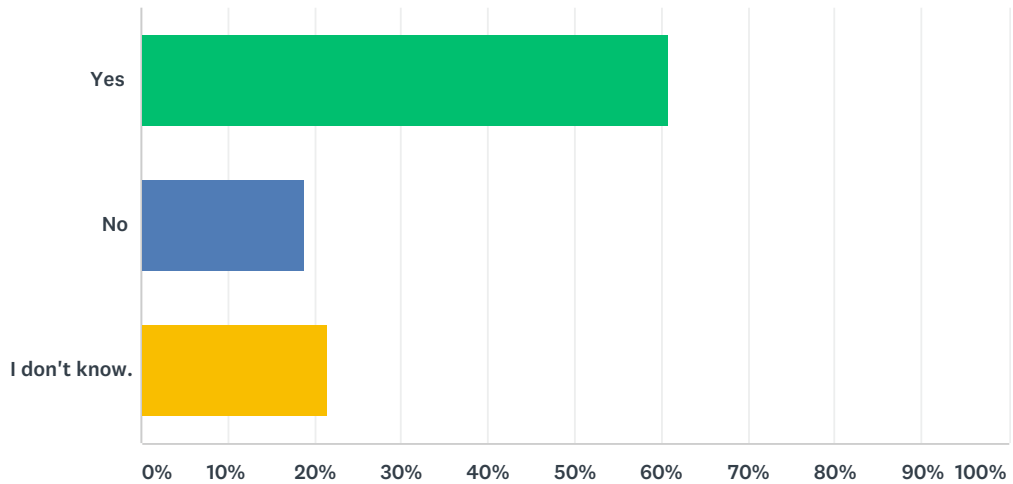

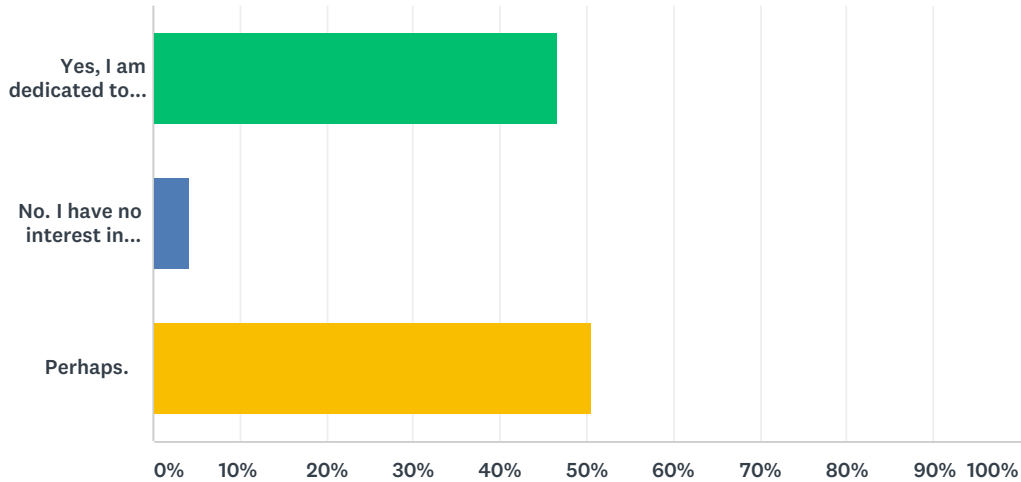

Q15 If the district were to provide training sessions on the three aspects of fundraising (cultivation, solicitation, and stewardship), would you attend?

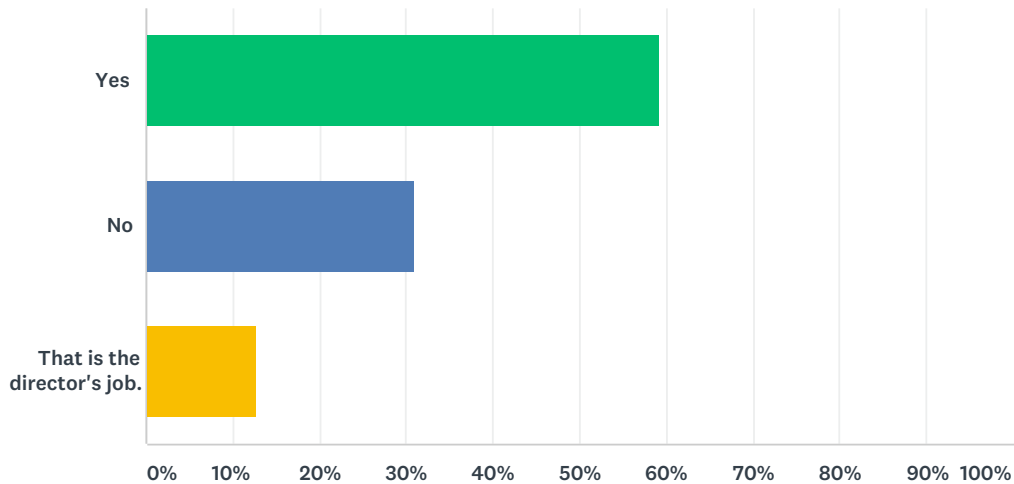
